THE AGREEMENT MADE THE _____ DAY OF _____ BETWEEN DOG-ON VACATION AND _____ (THE CUSTOMER) IS FOR SERVICE TO BE PROVIDED BY DOG-ON VACATION TO THE CUSTOMER IN CONNECTION WITH _____ THE PET(S). THE PARTIES AGREE AS FOLLOWS:

1. THE CUSTOMER REPRESENTS THAT THEIR PET(S) IS IN ALL RESPECTS HEALTHY AND HAS RECEIVED ALL REQUIRED AND CUSTOMARY SHOTS AND DOES NOT SUFFER FROM ANY DISABILITY, ILLNESS OR CONDITION WHICH COULD AFFECT THE PETS OR OTHER PETS TIME WITH DOG-ON VACATION.
2. THE FOLLOWING ARE THE SPECIAL CONDITIONS THAT DOG-ON VACATION SHALL OBSERVE OR BE AWARE OF WHEN PERFORMING SERVICES AND INCLUDES ALL SPECIAL CONDITIONS, BEHAVIOURAL CHARACTERISTICS, HANDLING REQUIREMENTS, AND OTHER MATTERS THAT SHOULD BE DISCLOSED BY THE CUSTOMER TO DOG-ON VACATION OR OF WHICH DOG-ON VACATION OUGHT TO BE AWARE IN CONNECTION WITH THE PET WHEN PERFORMING SERVICES (THE SPECIAL CONDITIONS):

THE CUSTOMER SHALL INDEMNIFY DOG-ON VACATION AGAINST CLAIMS MADE AGAINST DOG-ON VACATION OR LOSSES OR DAMAGES OF ANY KIND WHATSOEVER SUFFERED BY DOG-ON VACATION AS THE RESULT OF THE FAILURE OF THE CUSTOMER TO INFORM DOG-ON VACATION OF ANY SPECIAL CONDITION OF WHICH DOG-ON VACATION OUGHT TO BE MADE AWARE BY THE CUSTOMER IN CONNECTION WITH THE PERFORMANCE OF THE SERVICE BY DOG-ON VACATION.

3. DOG-ON VACATION SHALL NOT BE LIABLE FOR DEATH OR INJURY TO THE PET(S), DAMAGE OR INJURY CAUSED BY THE PET(S) TO PERSON, PROPERTY OR OTHER PETS WHILE THE PET(S) IS UNDER THE CARE AND CONTROL OF DOG-ON VACATION UNLESS THE DAMAGE OR INJURY IS A DIRECT RESULT OF THE GROSS NEGLIGENCE OF DOG-ON VACATION.
4. INITIAL EACH STATEMENT TO ACKNOWLEDGE YOUR UNDERSTANDING.

 - I RECOGNIZE THAT THERE ARE INHERENT RISKS OF DEATH, INJURY AND ILLNESS IN ANY ENVIROMENT ASSOCIATED WITH LIVE ANIMALS

 - I RECOGNIZE THAT SUCH RISKS INCLUDE BUT ARE NOT LIMITED TO DEATH, INJURIES OR ILLNESSES RESULTING FROM ROUGH PLAY, AIRBORNE CONTAGION, OUTSIDE FOOD SCRAPS, AND OTHER DOGS ON THE STREET
